Berlin, 19 July 2018. This year, Deutsche Wohnen SE has for the first time offered its shareholders the possibility to choose between the distribution of the dividend in cash or in new Deutsche Wohnen shares. During the subscription period, shareholders holding around 31% of the dividend-bearing shares opted for the scrip dividend. Accordingly, 2,241,061 new shares have been issued for around 111.2 million contributed dividend entitlements in an equivalent amount of around EUR 88.9 million.

Its operating focus is on managing and developing its portfolio, concentrating on residential properties. As at 31 March 2018 its portfolio comprised a total of 163,188 units, of which 160,723 are residential and 2,465 commercial. Deutsche Wohnen is listed on Deutsche Börse’s MDAX index and also traded on the leading indices EPRA/NAREIT, STOXX® Europe 600 and GPR 250.
